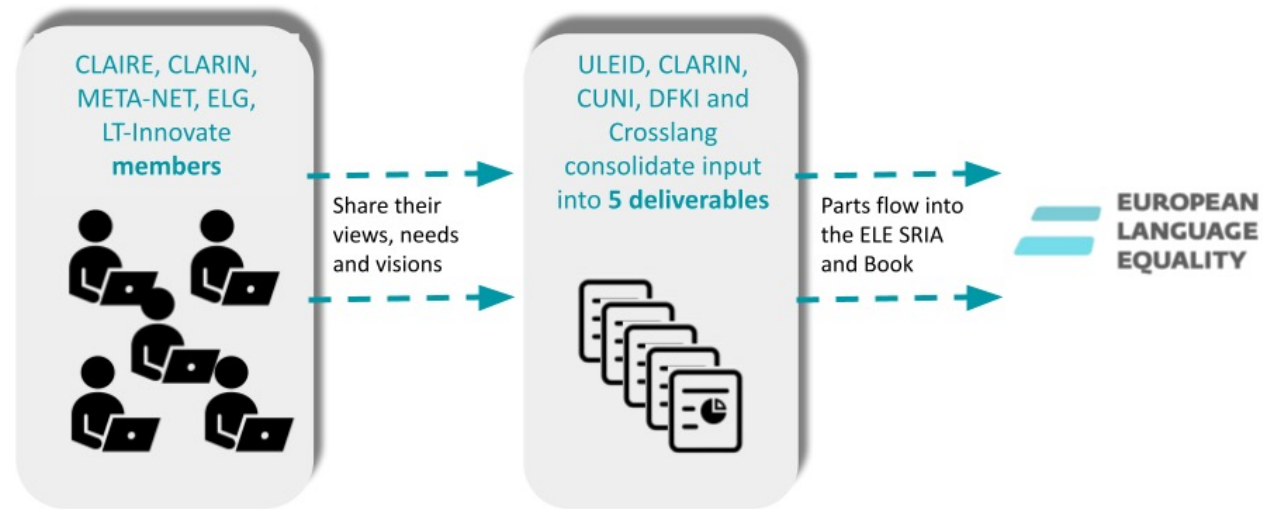

# Consultation with European LT developers

- **Objective:** to collect the views of European researchers and developers in the area of LT and AI; to consolidate their assessments of the strengths and weaknesses of the field and of the measures that need to be employed, so that all European languages are equally well supported through technology by 2030.
- **Instruments:**
  - Survey
  - Interviews
- **Disseminated** to members of CLARIN, CLAIRE, ELG, LT-innovate, META-NET (through ELE consortium partners) but also to the wider community

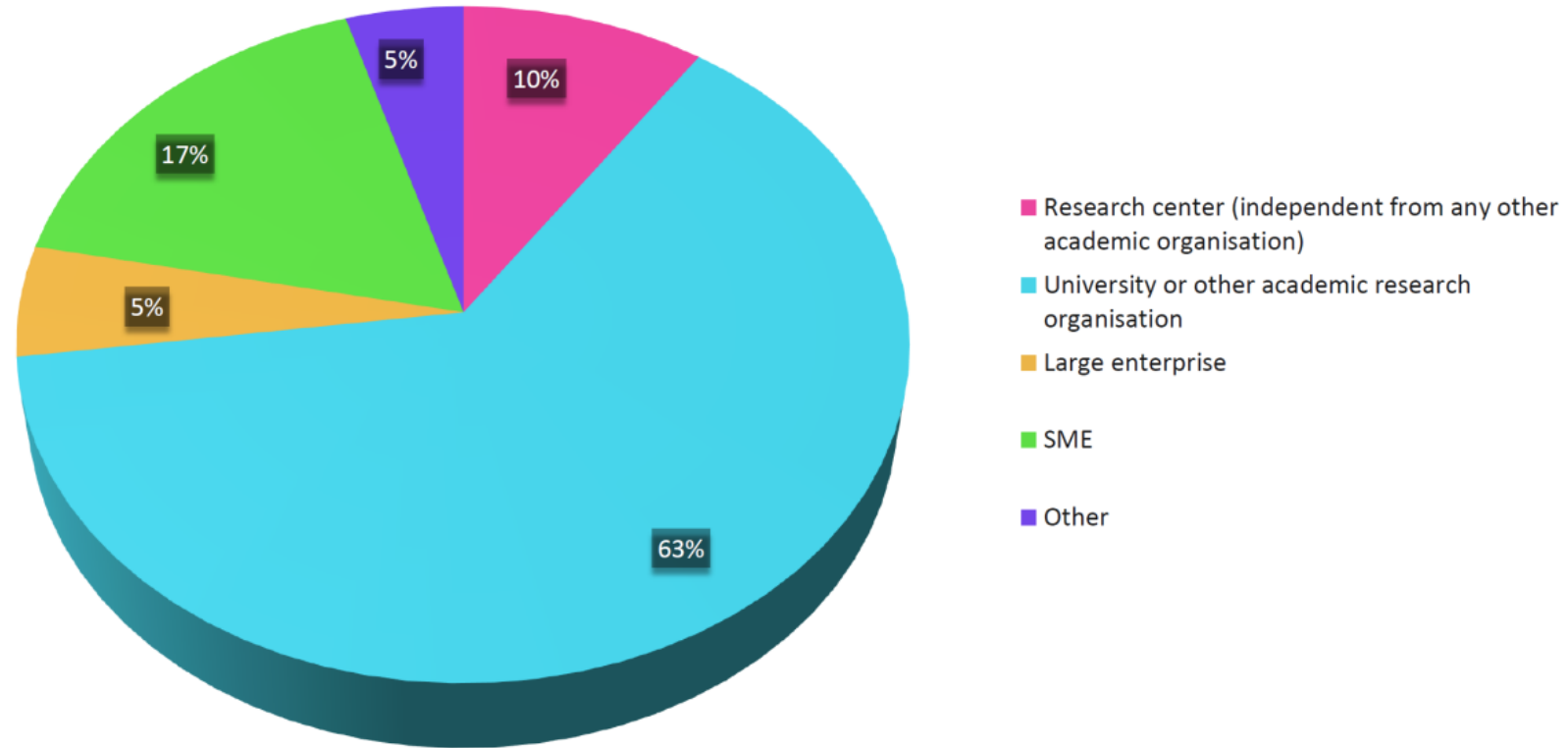

## Results: Respondents profiles

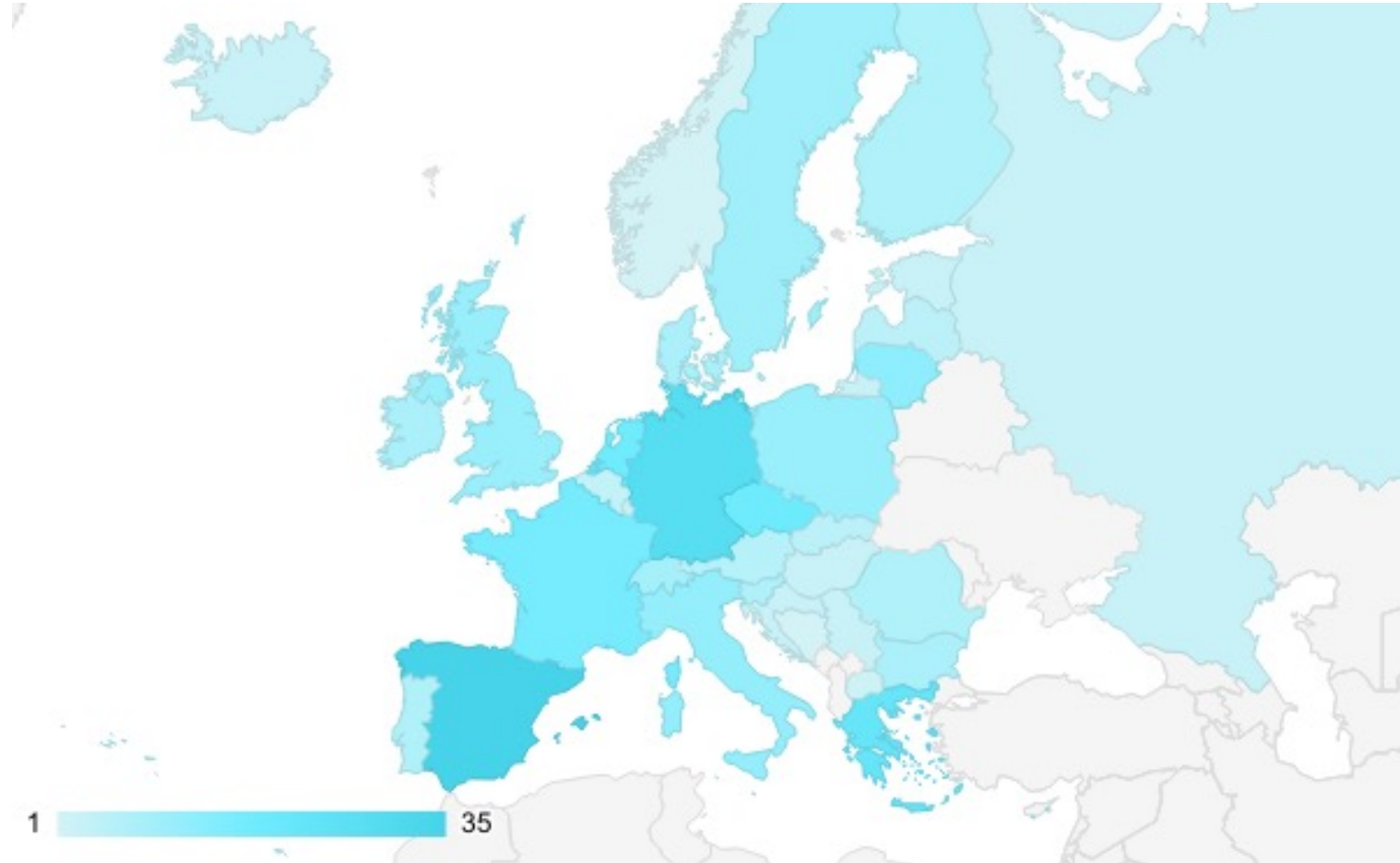
- 321 respondents

## Results: Respondents profiles

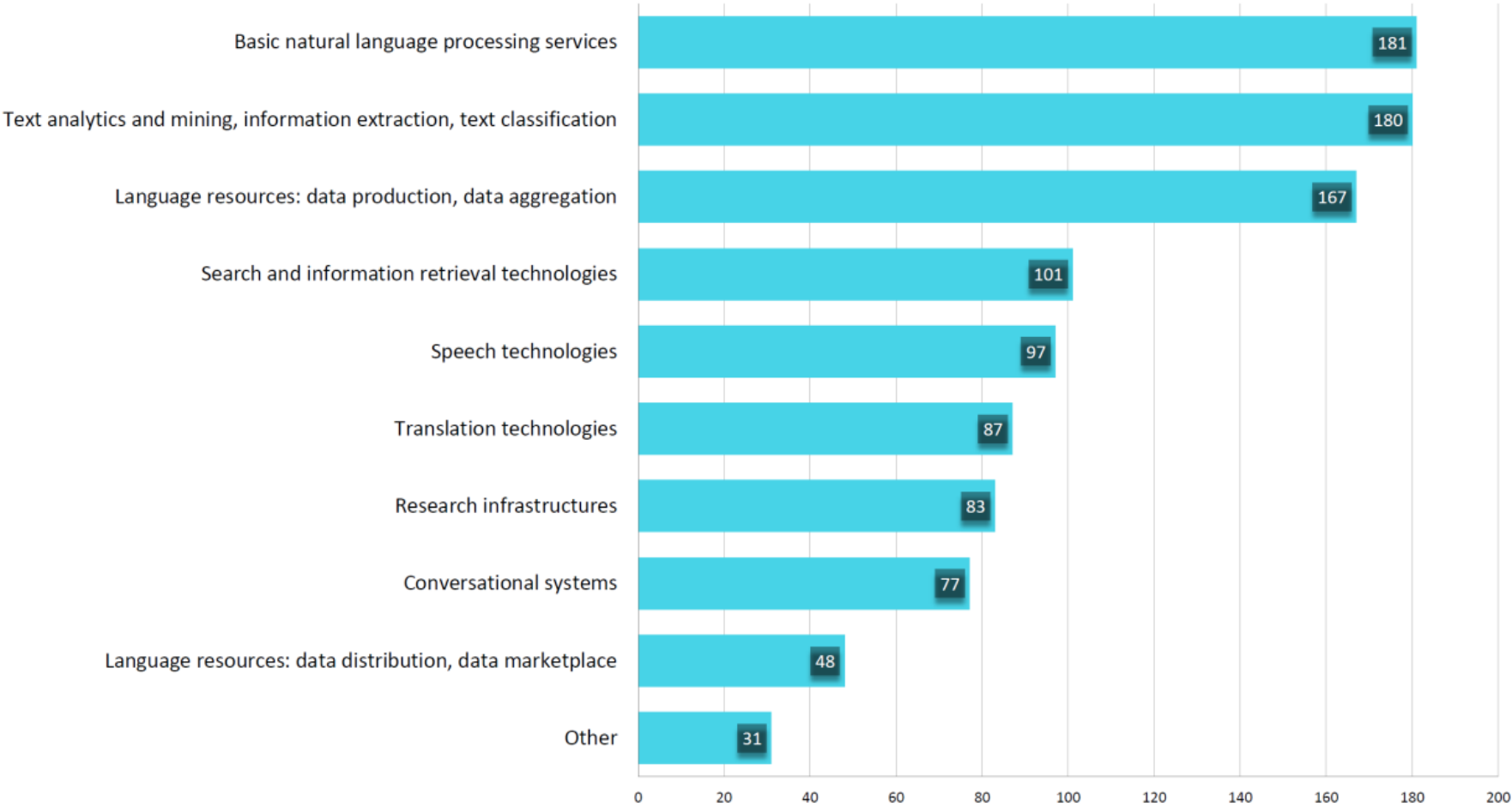
- all 24 EU MS covered plus other countries, e.g. UK, Iceland, Norway, Switzerland, Serbia, etc.
